

apotec® Refrigerator monitoring, Service Licence Terms

I. apotec® refrigerator monitoring Licence Terms

Licences are aimed exclusively at commercial end customers and not at consumers within the meaning of § 13 German Civil Code (BGB). The apotec[®] refrigerator monitoring fixed-term licence ("licence") allows you to use the following basic functions of the apotec[®] Refrigerator Monitoring Service (hereinafter referred to as "apotec[®] refrigerator monitoring") supplied by WEPA APOTHEKENBEDARF GmbH & Co. KG throughout the duration of the licence.

- · Use of all basic functions of apotec® refrigerator monitoring
- · Dashboard to monitor connected appliances graphical preparation of appliance data
- · Alert log with commentary function
- · Creation and storage of temperature reports
- · Configuration of alerts by e-mail
- · User and appliance management (role-based)

The licence only applies to an appliance which is compatible with apotec[®] refrigerator monitoring and may only be used in conjunction with a WEPA account. You require a separate licence for each appliance. The General Terms and Conditions of Use apply to the apotec[®] Refrigerator Monitoring Service (available at wepa.link/monitoring).

Further information on apotec® refrigerator monitoring is also provided at wepa.link/kühlschranküberwachung.

The licence key may be activated on the apotec[®] refrigerator monitoring dashboard for 3 years after receipt. The licence key will lapse following expiry of this deadline. The licence is valid for 12 or 36 months after activation depending on the contract. Your precise licence duration is stated in your order confirmation.

II. Additional Licence Terms for

a) Licence key cards

The fee for use of the licence must be paid in accordance with the provisions contained in the General Terms and Conditions of Use. If payment is not made in a timely manner, WEPA will be entitled to block the functions of the licence temporarily or to terminate the licence without notice in accordance with the General Terms and Conditions of Use.

No cash payment is possible.

b) Add-on SNS and telephone call notification licence

The prerequisite for use of the add-on SNS and telephone call notification licence (add-on licence) is at least one valid apotec[®] refrigerator monitoring licence. The add-on licence permits you to use the following additional apotec[®] refrigerator monitoring functions during the term of the apotec[®] refrigerator monitoring licence.

· Alert notification via SMS or by telephone call to selected recipients

The add-on licence applies to all connected appliances which are compatible with apotec[®] refrigerator monitoring and for which a valid apotec[®] refrigerator monitoring licence is in place.
